Important Requirements

1. Original fine art only. No dealers or commercially produced or imported items.
2. No applicant will be allowed to exhibit without a proper 10' x 10' white tent.
3. Vendors must move their cars from Pond Lane and Jobs Lane after unloading. There is free all day Village parking lot located next to the restrooms on the east side of the park.
4. New exhibitors are required to submit representative photos of the work you will be Showing and a photo of your booth (if available).

**** If these rules are not followed, SAA reserves the right to deny participation in the 2021 or any future Art in the Park shows. ****

Other Rules and Conditions

1. Only one artist per tent. Tent sharing is only permitted for family members.
2. This is a family-orientated show. All artwork should be in good taste. Any display deemed objectionable by the show committee or chairman must be removed. The show committee reserves the right to remove any display not conforming to the above condition.
3. Vendors must attend both days. No Early Breakdowns!
4. Space assignments will be emailed to you in advance of the show date. Do not move your tent assigned space without consulting Dom.
5. Tables must be covered with a clean table cloth. Exhibitors are responsible for keeping their space clean before, during the show and after breakdown.
6. No pets allowed by vendors at ANY time.
7. ALL VENDORS SHOULD HAVE A NYS RESALE #. For sales tax information access online at <https://www.tax.ny.gov>
8. No jewelry or crafts items (fine art only).

*SAA "Members Only" Tent:

- SAA Members may display a **maximum of three framed pieces at \$10 per piece.**
- A maximum of three unframed, matted bin items are also included in this price.
- Work must be labeled with artist's name, phone number, price and medium.
- All framed artwork must be wired and ready to hang. Bin items must be matted on a stiff backing protected in a plastic cover.

Notes:

Important: Overnight security will be provided by SAA for the night of July 10.

Restrooms & garbage containers are available on the park grounds.

Trash must be discarded in the receptacles provided.

Social distancing protocols will be followed.

Masks are mandatory.

Artist Must Sign Waiver: I understand & agree that the Southampton Artists Association, the Village of Southampton, Dom Lamontanaro and all volunteers and their legal representatives will not be held liable for any damage to my property and or person. I understand & agree that I alone am responsible for my property & person at all times at the "Art in the Park" 2021 art show. Items displayed will be handmade by me & only the type & category of work described on my application. I understand & agree that the Southampton Artists Association and/or Dom Lamontanaro retain the right to prohibit any exhibitor from exhibiting his or her work at the absolute discretion.
